INTERCULTURAL TRENDS RESEARCH

CROSS-CULTURAL REPORTING AND EUROMED MOBILITY – 5TH INTERCULTURAL TRENDS AND MEDIA PLATFORM



As the pandemic has fueled the spread of fake news, populist discourses and disinformation journalists, academics and civil society were brought together during the 5th Intercultural Trends and Media Platform organised by the Anna Lindh Foundation and the Mediterranean Universities Union (UNIMED) on 8 April 2021.

The discussion focused on media coverage on migration, mobility and coexistence within multicultural societies in the Euro-Mediterranean region.

During the meeting, the Anna Lindh Foundation offered participants insights from the latest ALF-Ipsos Intercultural Trends Survey 2020 which gathered the views of over 13.000 people from the region. Some of the statistics help to offer evidence contradictory to certain narratives dominating the news-cycle. Specifically, on the theme of migration, the Intercultural Trends Survey of 2020 reveals that 40% of Europeans would stay in their country of origin if they would be given the chance to start a new life somewhere else whilst the same number in the Southern and Eastern Mediterranean was 49%. Furthermore, of these people only 20% would like to go to Europe.

During the roundtable, reflections some of the issues highlighted include:

- Covid-19 has made encounters between journalists and people at the grassroots level more challenging, which is problematic as journalists depend on talking to people in different life situations, including migrants which found themselves in a particularly vulnerable situation. In this regard, it was also highlighted that the restrictions to travel presents an obstacle to foreign reporting on migration and data-collection for academic purposes.
- Journalists often face difficulties with editors to publish stories on migration at a time where news focus is on issues related to the pandemic.
- While migrants do receive some press coverage after having arrived in the destination country few articles cover their journey from the country of origin.
- Migrant communities have also been blamed for high infection rates Covid-19, which may lead to stigmatization and migration, is too often portrayed in the media as a problem. The following recommendations were expressed, with regards to how the Foundation and other actors in society could promote nuanced and dialogue-driven media discourses.
- More testimonies and stories from migrants themselves are needed for a nuanced public debate on the issue. Furthermore, more attention needs to be given to the initiatives led by migrants themselves promoting integration.
- More media coverage is needed to shed light on the equal distribution of vaccines so that migrant communities would not end up treated worse than the majority population.
- The media should bring nuance to the public debates on migration by telling the stories of for example, families staying in their countries despite difficulties with the pandemic or otherwise.
- Media literacy is important in order to promote dialogue and mutual understanding in the media.
- Education is crucial to promote dialogue and diversity and one way of doing so is through mixed schools where children of migrants and the host communities go together. □

PREPARATIONS UNDER WAY FOR SIXTH INTERCULTURAL TRENDS AND MEDIA PLATFORM

The next edition of the Intercultural Trends and Media Platform will take place on the 18th of May and it will focus on cross-cultural reporting on environmental issues and climate change. □

DISCUSSING HATE SPEECH AT THE THIRD INTERCULTURAL MORNING COFFEE ON THE 21ST OF APRIL

The Third Intercultural Morning Coffee brought together two alumni of the Intercultural Trends and Media Platforms to discuss and reflect on issues relating to diversity in cities and the media's portrayals of cultural, religious and ethnic minorities.

The meeting started with a brief presentation by Atte Oksanen, contributing author for the Fourth Anna Lindh Intercultural Trends Report. In his introduction, Oksanen gave an overview about how research on hate speech has developed during the last 10 years and the challenges that hate speech poses in the Euro-Mediterranean area. During the meeting it was noted that hate speech online has evolved from a marginalized and fringe phenomenon to something mainstream and common. This is seen in how journalists and academics are targeted online. Something equally worrying is also that these people targeted do not always report their experiences to the authorities.

Concerns were also raised with regards to social media being used as the main source for news for many people. Yet, it was also recognized that, at times, social media has offered a platform for information sharing that permitted free speech and exchange of information in an otherwise censored media landscape.

Specifically, regarding the issue of migration, it was recognized that social media is a particularly powerful forum that shapes public perceptions, even though it would not be the only used source of news online. Hence, a challenge is not only to counter fake news but to counter fake impressions and perceptions, regarding for example, the phenomena that push migrants to leave their countries of origin.

With regards to promoting living together in multicultural settings, it was noted, based on the findings of the Intercultural Trends Survey of 2020, that one's level of religiosity was not necessarily correlating with one's level of tolerance towards others, which was much more essential in determining people's values vis-à-vis diversity.

With regards to polarization in our societies and in online communities, it was also noted that acceleration of hate speech does not happen overnight but instead is a slow and steady process, of which there is a history as well particularly in Europe.

Regulations on social media were considered as both a threat and an opportunity. On the one hand, regulations may lead to

a decrease in hate speech. But, on the other hand they may lead to censorship of free speech.

Recommendations

- It is encouraging to see that the European Commission is taking measures to tackle hate speech, misinformation and disinformation
- More discussions are needed on how to encourage and engage social media companies to regulate the content published on their websites, especially illegal material that is inciting violence. □

LAUNCH OF THE ANNA LINDH INTERCULTURAL TRENDS DATA HUB

The Anna Lindh Foundation launched the Intercultural Trends Data Hub which permits users to review and compare data from the Intercultural Trends Survey in 2020 along with the three earlier editions of the Survey. All five editions of the Survey are based on a combination of polling with more than 52,000 citizens in the EuroMed countries.

“By examining values and social change for the last 10+ years, users of the Intercultural Trends Data Hub may discover many interesting correlations and patterns that could suggest new research questions and areas of study. Users may also discover that countries that are geographically far apart are in fact very similar with regards to the values respondents hold”, said Eleonora Insalaco, Head of Operations and Intercultural Research at the Anna Lindh Foundation when describing the Intercultural Trends Data Hub at the Welcome Webinar of the online course on Intercultural Trends in the Euro-Mediterranean.

FOURTH EDITION OF THE INTERCULTURAL TRENDS REPORT – PROGRESS:

The ALF received in March all draft analytical articles by identified authors to the Anna Lindh Report 2021. The articles are currently being edited. To support the authors with drafting the articles and using the Intercultural Trends Data Hub, Ipsos MORI organized virtual drop-in-sessions. Authors of the Report have also been requested to make 3 minutes videos – sharing some of the reflections/key findings already presented in your articles for the Report and these audio-visual materials will be integrated into the Online course on Intercultural Trends in the EuroMed region. □

FOURTH EDITION OF THE COURSE ON INTERCULTURAL TRENDS IN THE EURO-MEDITERRANEAN



The Fourth edition of the course on Intercultural Trends in the Euro-Mediterranean started on the 15th March and ran until the 11th of April. The course received 192 registrations. 68% of these were females and 30% were males. 56% were under 34 years old they hailed from 36 countries in the Euro-Mediterranean and beyond.

This edition of the course was also joined by 12 students from the University of Siena undertaking a master's programme in cultural and public diplomacy.

The course is composed of four modules:

Module 1: Representation of the Mediterranean and Mutual Interest. Through this module, you will learn about common values and attitudes, interests and expectations of the people living in the EuroMed region and their perception towards other countries/people.

Module 2: Values and Mutual Perception. Through this module, you will learn what are the most important values for people living around the Mediterranean and how the role of women is perceived and is expected to change.

Module 3: Interaction across Cultures. Through this module, you will learn about how people from the two shores of the Mediterranean interact and how they construct the representation of the "other" as well as the role of media in this process.

Module 4: Living in Diversity. Through this module, you will learn about the impact of religion on people's point of view and what could be efficient actions to tackle radicalisation and for better living in multi-cultural cities and societies.

During the course a welcome webinar was organised on 18 March which attracted the participation of 46 learners.

Furthermore, the course includes two online meetups of which the first one was organised on 25 March and the second one on 8 April.

ACADEMIC COURSE ON INTERCULTURAL TRENDS

On 11 March, 2021, the Head of Operations and Intercultural Research at the Anna Lindh Foundation gave a lecture as part of a course on cultural diplomacy at the Department of Social, Political and Cognitive Sciences of the University of Siena. The course offers students an overview of the main approaches and concepts in cultural diplomacy, mixing a historical perspective with the study of contemporary practices in the framework of diplomatic, sociological, cultural and communication studies. Polling data from the most recent edition of the Intercultural Trends Survey published in 2020 along with earlier editions of the Survey published in 2010, 2014 and 2018 and an overview on the ALF research work was presented.

In the framework of the course, the University of Siena is piloting a course on Intercultural Trends based on the online course on Intercultural Trends in the EuroMed developed in collaboration with UNIMED.

The presentation was the first public event since the passing of the Executive Director Dr. Nabil Al Sharif. During the lecture, Insalaco highlighted Al Sharif's effort to promote diversity and mutual understanding in all four corners of the Euro-Mediterranean whilst also working tirelessly for the empowerment of particularly youth and women in the region. □

QUO VADIS EURO-MED CIVIL SOCIETY WEBINAR - HONOURING EXECUTIVE DIRECTOR DR. NABIL AL-SHARIF AND DISCUSSING THE STATE OF CIVIL SOCIETY IN THE EURO-MEDITERRANEAN



In the framework of the “Quo Vadis Euro-Med Civil Society” webinar as part of one of the ALF CFP funded projects, the Head of Operations and Intercultural Research, participated in a panel discussion on the current state and perspectives for civil society work in the EuroMed region together with Dr Rowaida Al-Maaitah, Professor at Jordan University of Science and Technology; Alison Surtees, Creative Producer at In Place of War, Dimitrios Triantaphyllou, Professor of International Relations and Director of the Center for International and European Studies at the Centre for International and European Studies (CIES), Kadir Has University, Istanbul and Josep Ferré, Director General at the European Institute for the Mediterranean (IEMed) Barcelona.

At the opening of the meeting and on behalf of the panellists, Ms. Insalaco paid tribute to the recently passed Executive Director of the Anna Lindh Foundation, Dr. Nabil Al-Sharif. During the panel discussion, Insalaco reaffirmed the intention of the Anna Lindh Foundation to support civil society in the management of pressing social challenges related to the impact of the current pandemic and climate change. Furthermore, she noted that the pandemic has also created some conditions which can favour dialogue work as people had to step out of their comfort zone to think about new methods for their work. □

PROGRESS WITH FUNDED EUROMED INTERCULTURAL TRENDS RESEARCH COLLABORATIONS

The Anna Lindh Foundation is currently funding three Intercultural Research collaborations. The selected projects are “Global Crises, Common Problems, Collective Solutions” implemented by a consortium led by the Centre for International and European Studies (CIES); *LEILA Research* (Arabic Books in European Languages) implemented by a consortium led by Literature Across Frontiers (LAF); and “Climate Change and Migration in EuroMed region: Socio-Economic Development and Intercultural Perspective” implemented by a consortium led by the University of Calabria (UNICAL).

To date the Anna Lindh Foundation has organised a number of coordination meetings with the organisations carrying out the research projects. □

REPORTING TO THE GERMAN FEDERAL FOREIGN OFFICE ON THE ACCOMPLISHMENT OF THE LAUNCH OF THE INTERCULTURAL TRENDS SURVEY AND THE PUBLIC POLICY FORUM ON THE SECOND OF DECEMBER

During the month of March, a full and comprehensive report was produced on the activities held on 2 December 2020, during which the Intercultural Trends Survey was launched and a Public Policy Forum on Youth and Civil Society in the EuroMed were organised. This report was submitted to the German Federal Foreign Office which funded part of the costs of the activities.

The report included segments on the regional context of the events, in-depth description of the activities, outline of the preparations and logistics, analysis of the media campaign and communication measures along with stories from the ground and all visuals and social media templates developed for the events. □

REPORTING TO DONORS AND ASSESSING PROGRESS FOR THE EUROPEAN COMMISSION

REVISION OF ALF LOGICAL FRAMEWORK WITH EC COMMISSIONED EVALUATOR

The ALF has finalized a process of revision of the Logical Framework included in the Action Grants signed with the European Commission, this process was initiated by the European Commission with the appointment of an external evaluation and to date two meetings were held with the EC evaluator in this regard. □

INTERCULTURAL CITIES AND LEARNING

FIRST STEPS TOWARDS ESTABLISHING THE ANNA LINDH EUROMED CAPITAL FOR DIALOGUE AWARD

On 4 March 2021, the ALF brought together experts and strategic partners to discuss the launch of the EuroMed Capital for Dialogue Award, which aims to recognize and promote the work that cities and local actors do in promoting intercultural dialogue in the region.

Experts and strategic partners participating in the meeting included: Mohamed Boudra from Al Hoceima Municipality in Morocco and UCGL; Irena Guidikova from the Council of Europe; Linda Tinio-Le Douari from UNESCO; Nicola Vaththae from Eurocities; Giulia Marchesini from Center for Mediterranean Integration (CMI); Aliko Moschis Gauguet, from the Anna Lindh Foundation's Advisory Council; Ricard Zapata-Barrero from Universitat Pompeu Fabra; Sena Segbedzi from the OECD and Douglas Ragan from UN-Habitat, Oriol Barba Suño from MedCities.

During the roundtable experts and strategic partners underlined the importance of designing a clear methodology and a roadmap for selecting the winner of the EuroMed Capital for Dialogue Award with an evaluation mechanism which could value current measures in relation to diversity management as well as the vision and proposals for enhancing diversity management and intercultural dialogue with a EuroMed dimension.

The meeting offered a first platform to all participating institutions to share their programmes and priorities for the promotion of dialogue and city-to-city collaboration and this was considered as a first step to ensure coordination between the different existing schemes with a need to disseminate information on them to all the potential stakeholders.

The Anna Lindh Foundation is committed to facilitate further this exchange and to bring together local authorities, civil society, academics, educators and media for the exchange of know-how and the setting up of local platforms for dialogue across the EuroMed region. Operations and policies used by international organizations at the city-to-city level were also presented. □

DIGITAL GAME ON INTERCULTURAL CITIZENSHIP EDUCATION

In the framework of the ALF Intercultural Learning and Cities Programme and against the backdrop of restrictions brought on by the pandemic, the ALF is in the process of commissioning the production of a digital game on Intercultural Citizenship

Education in the EuroMed region based on the learning activities and principles presented in the Anna Lindh Foundation Education Handbook.

This game will be available in English, French and Arabic. The service provider will also offer workshops on how to use the game to educators in the formal and non-formal education sector. □

CANDIDATURES - VIRTUAL REGIONAL TRAINING FOR TRAINERS ON INTERCULTURAL CITIZENSHIP EDUCATION IN THE EURO-MEDITERRANEAN REGION

In the framework of the Anna Lindh Foundation Intercultural Learning and Cities Programme aiming at preparing people of the region to live and be active within multi-cultural societies, and due to the Covid19 restrictions for face-to-face training activities, the Anna Lindh Foundation is organising the first Virtual Regional Training for Trainers on Intercultural Citizenship Education in the Euro-Mediterranean region (29 May - 26 June 2021).

The training is addressed to educators in the formal and non-formal education sector and is based on the capacity building methodology on intercultural dialogue developed by a team of experts coordinated by the Anna Lindh Foundation having as main educational reference the Anna Lindh Foundation *Education Handbook on Intercultural Citizenship in the Euro-Med region*.

The training will be carried out in English to ensure participants have a common language for participating in all the interactive sessions. The training will be held virtually and will last for 6 sessions, scheduled from 29 May to 26 June 2021. The 6 live training sessions will be held every Saturday from 10:00 to 13:00 (CET). In addition, weekly offline groups and/or individual 2- hour sessions among trainers and educators will be held at the participants' pace. A final evaluation and follow-up session will be scheduled during the last week of September 2021 and is considered as an integral part of the Training.

Following the virtual training, educators should commit to implement a training activity based on the Regional ToT in their respective communities and networks and will be accompanied in this process through a mentorship scheme coordinated by the Anna Lindh Foundation. The training activity by each trained educator is to be implemented between 20 June and 10 July 2021.

For the selection of educators to attend the Virtual ToT, the Anna Lindh Foundation launched in March to the Heads of Network a call to educators in each Member States. The

deadline for applying is on the 24 April 2021 at 17h (Egypt time).

Through this Call the ALF will select 20 participants for the Training for Trainers. Participants will be selected on the basis of the following criteria:

1. Being an educator.
2. Work in the formal or non-formal education sectors.
3. Work with young people.
4. be able to organise and conduct training for other groups.
5. be familiar with non-formal education pedagogical approaches.

Additionally, participants should:

1. Have developed projects for intercultural citizenship education, or have been involved in projects for intercultural citizenship education, and
2. Have worked on issues related to intercultural citizenship education (e.g. diversity, identity, citizenship, active participation, intercultural dialogue, etc.) and
3. be committed to organise educational activities in 2021 in their country and with the ALF network as part of the training and as follow-up to it

Lastly, based on the relevance and quality of applications, the Anna Lindh Foundation will try to ensure the selection of representatives from different countries of the region with a tentative ratio of 7 Southern Mediterranean and 13 European participants and with gender balance. □

CALL FOR EXPRESSION OF INTEREST - FIRST PILOT VIRTUAL TRAINING ON INTERCULTURAL CITIZENSHIP EDUCATION

On 4 March the ALF launched a Call for Expression of Interest to the trained educators during the 2019 Nicosia Regional Training for Trainers on Intercultural Citizenship Education in the EuroMed region as part of the related mentorship scheme. The ALF sets to support through a single tendering procedure the development of a pilot virtual training on intercultural citizenship education led by educators trained in the Region ToT. The organisation of the pilot virtual training responds to: The needs arising from the outburst of the Covid19 pandemic and the increased potential of the use of new technologies for training purposes as well as the limitations for face-to-face training activities; The need of providing opportunities to the educators trained within the Regional ALF ToT to implement the acquired competences and knowledge of the Anna Lindh Foundation Education Handbook; Finally, to the need of disseminating to other educators, young people and civil society information, competences, skills, and attitudes related to intercultural citizenship education and to the ALF Education Handbook as a reference resource. □

ANNA LINDH FOUNDATION VIRTUAL MARATHON FOR DIALOGUE IN THE EUROMED



From January to April, the Virtual Marathon has started to be shaped, according to the concept note developed and shared with the Network, in particular with the HoN, during their meetings of November and December 2020.

The spine column of the Virtual Marathon is a series of 7 webinars on-line to take place once the week, on the Wednesday, during 42 days from the 19th of May to the 29th of June. A platform will be organized, through the Secretariat, to ensure a smooth development of the activities and a good level of participation, quantity and quality wise.

Around the 7 webinars, the members of the Network, as well as partner organizations, will organize national or cross networks activities. - A social, as well as a traditional media campaign/s, implemented by an external service provider, will ensure the coverage of the whole Marathon.

In order to make the process as participatory as possible, a coordination Committee, made of the coordination team, the Network Department, the contract and finance area, as well as of the Operations Area, has been meeting once the week to further elaborate the concept and the mechanism of mobilisation and make it workable.

From February to April, different calls were launched: two tender procedures, to hire on one hand a Media campaign/s provider to spread the Virtual Marathon information and on another hand the provider of the platform to enable the activities to happen on-line in the best conditions. In the meantime, a third procedure was launched, A CALL for expression of interest, through direct mails to the members, as well as through the social media (Facebook, Instagram, Twitter) – given the technical problems with the web -, in order the Network/s members to present activities in the framework of the Marathon. It is indeed very important that all the members are well informed and a lot of efforts have been put in this direction.

Last, not least, the programme of the webinar has been worked out, content and format wise and High-level Representatives, as well as panellists, such as youth, decision makers, civil society organisers, academicians, journalists and business sector, are being invited. □

Hosting (virtually) 27 young people from 18 countries of the Euro-Med, Taking place on January 25-19th, 2021, the Seminar represented the anchor event in YMV’s capacity-building process. The components of the regional training, leading through values, cultural intelligence, advocacy, and media and outreach, in addition to providing participants with direct exposure to established leaders and EU policy-makers, create a rich array of experience. Programme partners, including the Anna Lindh Foundation, MEDAC, Club de Madrid and the British Council, contributed to the establishment of hub for regional visibility in the domain of youth voice and leadership.

Three Regional Leadership Seminars were organized over the three year time-frame of YMV, with the first of the Seminars, which took place in Malta in January 14-18, 2019 coinciding with the 5 + 5 Ministerial Dialogue, which also took place in Malta on 18-19 January 2019. The Second Seminar took place in Malta in November 17-23, 2019.

The methodology of the activity, modified and refined through the three editions of the Seminar by partners, participants and general stakeholders, was extended to 2021 with appropriate modifications, relating also with the pandemic and its restrictions. The methodology took on board the needs of YMV Alumni, considering an experience stemming from the debating skills to dialogue and aiming for a leadership development experience.

The conversation and generation of policy recommendations was around selected SDGs, which reflect the main concerns of youth in the region as identified in a number of YMV events, amongst which, the Debate Forum (Nov. 2020):

- SDG4: Quality Education
- SDG8: Decent Work and Economic Growth
- SDG10: Reduction of Inequality within and among countries
- SDG16: Peace, Justice and Strong Institutions.

Programme partners met on March 22nd, in an online meeting to celebrate the Young Mediterranean Voices programme and its accomplishments. After 39 months of continuous activity, the programme completes the current cycle and starts to plan for the future!

Since the launch of the programme in 2018, more than 9,000 young people were trained and participated in the dialogue and debating activities of the programme, from all over the Euro-Mediterranean region, activities have taken place in 33 countries and 100 towns and communities in the Euro-Med, 177 young people have been mobilized in inter-regional activities, 14 dialogue events (live and virtual) have taken place involving high level decision-makers, three regional Leadership seminars and 3 strategic communications Labs, new partnerships and collaborations have formulated and continue to develop.

The first four months of 2021 have been dedicated to closely following up on the implementation of the projects awarded within the framework of ALF 2020 Call for Proposals (CfP) – Intercultural Dialogue Initiatives.

Furthermore, the Grants team has been meeting regularly with the Monitoring & Evaluation (M&E) Manager regarding the M&E software that is currently being developed. The Grants unit has had the chance to recently test this new tool that is aimed at supporting CfP grantees in the management of their respective projects during both the implementation and the reporting phases.

Finally, the team is working to be able to set up a format that would allow CfP grantees to meet and find synergies among their projects. □



International Women's Day campaign

The Grants Team held individual meetings with each of the 36 leaders to discuss their projects and provide some guidance on the frequently asked questions that arise during the implementation phase. Further, the team has had the opportunity to attend high-quality events organized by the grantees within the framework of their projects.

In an effort to increase the visibility of the awarded projects, the team, in close collaboration with ALF Communication Unit, organised an online communication campaign for International Women's Day that spanned over the months of March and April. On this occasion, projects that tackle gender issues and foster women's agency were showcased on ALF social media. During the next quarter, the team will keep shedding light on more CfP projects on different International Days and occasions.

In parallel, the team has worked jointly with the Networks team to arrange capacity building sessions that have unfortunately been delayed due to the tragic events ALF faced in January and March. However, the two teams keep working closely on the preparation of these sessions that CfP grantees and ALF members would benefit from in the coming months.

Start to Listen Project

With the project “[Start to listen](#)”, Grenzenlos, Citizens in Action, Kayan Feminist Organization and Hayya Bina provide young people the possibility to learn and exchange about **Gender Equality**. While producing different podcast episodes, they want to empower participants to be active citizens who foster gender equality through their actions. In the project, young people learn to express their ideas and perspectives about the status quo of gender equality in their societies. Through the exchange with project participants from other countries, they do not only gain a better understanding of their own culture but also hear about the reality of gender equality in other parts of the world. Moreover, the media often discusses gender roles and equality in a populist manner. Hence, the project includes workshops that aim at helping the participants to question media prejudices and to identify fake news. At the same time, they learn how to create reliable content and share it with an online community.

The project started with an online kick-off event in October last year. In April and May, the local youth groups are meeting in their respective countries to work on said podcast episodes. Due to the ongoing health crisis, the meetings take place either in person or in a virtual format, depending on the local circumstances. The podcasts, including the interviews the young people recorded, will be published on 15 June 2021. Follow the project here to not miss out on more information. □

What is the Christmas Souk in concrete terms?

It is a forum of intercultural exchanges between Mauritanian, Tunisian, Luxembourgian and Belgian associations. The forum will present the following themes:

- Youth, education and training
- Gender and women's rights

The main objective of the forum is to foster encounters, entice reflections, spark debates and exchange ideas around these three major themes; which are at the heart of the values promoted by the Anna Lindh Foundation.

This event will be accompanied by a Mediterranean-tinted associative souk (an activity fair that hosts various associations active in the Foundation and in Belgium). □



ASSOCIATION FOR SOCIAL RESEARCH AND COMMUNICATIONS SARAJEVO (UDIK) REMEMBRANCE OF HOLOCAUST VICTIMS



On the occasion of January 27, Holocaust Remembrance Day, the Association for Social Research and Communications (UDIK) presented a new book entitled "Sarajevo: Remembrance of Holocaust Victims". The book documents the names of fallen fighters, citizens of Sarajevo in the National Liberation War, fallen fighters for the liberation of Sarajevo and victims of fascist

terror. The list of names was obtained from the newspaper *Oslobodjenje*, which published the same list last year when a mass for Bleiburg was held in the Sarajevo Cathedral. Vildana Selimbegović, editor-in-chief of *Oslobodjenje*, wrote about the data collection process in the introductory part of this book. For the needs of this book, the hazan of the Sarajevo synagogue, Igor Bencion Kožemjakin, wrote a text called *The Jews of Sarajevo, Victims of Nazi and Ustasha Terror*, which is at the end of the book. □

ONLINE PLATFORM FRKA.BA



The online platform *frka.ba* was launched, which is also the first such platform for the promotion of young artists in Bosnia and Herzegovina. This idea came to a group of young people from 7 local communities (Brčko, Zenica, Foča, Prijedor, Zvornik, Gradačac, Novi Grad), which aims to bring together young artists in one place (Web, Facebook, Instagram, YouTube). Members of the Youth Resource Center (ORC) Tuzla are one of the founders of the initiative: Adnan Karamujić and Ammar Grabić.

Digital channels of communication and promotion are something that has long been recognized as a necessity in the further development of any type of business. This was especially evident during the crisis caused by the Covid-19 pandemic. The platform "FRKA" (Facade Recreational Creative Artists), above all, gives media space to young people who do not have the opportunity to show their talent to the general public, and on the other hand is the space of educating the public about different arts in our country. Regardless of the dominant focus on social networks and online activities, it also continuously strives to provide young people from all over BiH with the opportunity to work in the field by recording podcasts and outlining murals, which promote art and cultural values.

"Our vision is for frka.ba to become a place, not only for the promotion of art, but also a space for interconnection and communication, as well as empowering young people through art. Whether it was painting, music, graphic design, photography, or something that has not been seen in our country so far, we are aware that art is a living thing, and that it is more than a vocation or a job." - point out the representatives of FRKA.

“ What shall we do to respond to the challenges women face because of gender inequalities? We need to talk about it – talking to our mothers and sisters – I’m sure this workshop will change my mentality 100% and I will share what I learnt with [others/friends].

“ The woman is the person who should define what empowerment means – empowerment many times has a meaning that is too focused on privileged women and giving more privilege to these women – smaller schemes: empowering women to cook and plant – not to force women to look a certain way or have a certain job – you should ask women what they want – age and context is very important.

“ P: the whole journey [of the workshops] made my journey seem less lonely – having others with the same visions and aspirations – makes our work less lonely and it inspires me to do more.

Building Healthy Relationships and Enhancing Gender Equality

Women from Cyprus, Egypt, Lebanon and Jordan came together in the online seminar Building healthy relationships and enhancing gender equality. “The whole journey [of the workshops] made my journey seem less lonely – having others with the same visions and aspirations – makes our work less lonely and it inspires me to do more”, a participant mentioned on her experience. The seminar was addressed to women aged 18-25 from Cyprus, Egypt, Lebanon and Jordan, and was divided in two sessions with a series of online meetings between December 2020 and March 2021.

Organised on the occasion of the 25th anniversary of the Barcelona Process by the Anna Lindh Foundation and the heads of the ALF networks of Cyprus, Egypt, Lebanon and Jordan, the seminar had the financial support of the Ministry of Foreign Affairs of Cyprus. The seminar was coordinated by the Heads of the Anna Lindh Foundation Cyprus Network, and implemented by the Cyprus Family Planning Association and the Mediterranean Institute of Gender Studies and their experienced trainers.

The selection of participants was made through an open call, with a final selection of 40 women. Through the use of non-formal education methodologies and interactive tools, the participating women became informed about decisions on gender stereotypes and building healthy relationships based on respect; as one participant pointed out, “acknowledging our human rights in a deeper way...and to learn more things about consent is very important for our lives”. Participants also had the opportunity to speak with Mr. Samir Anouti, Regional Adviser for Youth & HIV/AIDS of the United Nations Population Fund (UNFPA) about the programmes offered by UNFPA in the Arab region to support women’s health and rights.

Women who participated in the seminar were eager to continue working together and advocate for women’s rights and finding more opportunities to share their voices. “[We want to take this further] to promote programs like this amazing program in order to empower women...to promote more documentaries for women’s achievements and women’s fights...In order to make womanhood stronger and make each woman love and admire each other as it should”, remarked one of the participants. □

The Anna Lindh Foundation Cyprus Network is organising a series of five capacity building workshops for network members from February until June 2021, reflecting the needs and interests of the network.

ALF MULTI-COUNTRY YOUTH DEBATE: STRENGTHENING YOUTH CIVIC ENGAGEMENT IN THE EUROMED



The Cyprus Network of the Anna Lindh Foundation organises a multi-country youth debate addressing the issue of Youth Civic Engagement in the EuroMed.

Training to the members of the French network

In the framework of the assistance program dedicated to the members of the Anna Lindh Foundation French network, the European Association for Local Democracy (ALDA) has provided a training to the members of the French network on the topic "Multiannual Financial Framework 2021-2027: Which opportunities? "With the support of the Forum Femmes Méditerranée, leader of the French network. This training took place on Thursday, February 4, 2021 from 9:00 am to 1:00 pm in a hybrid format: participants were gathered both in person in Strasbourg (11 people) and online through videoconference (9 people).

ALDA experts introduced the participants to the new Multiannual financial framework of the European Union, its functioning and the next funding opportunities, giving a detailed overview of the chapters and the funds planned for the period 2021-2027. Subsequently, the participants were asked to put into practice what they had learned, through a simulation of a European funding application - gathered in groups, they defined together a cooperation project proposal. The participants had the opportunity to exchange and debate on the different points discussed during the training. This learning was completed in the afternoon by a presentation of the functioning of the European institutions (Council of Europe, European Parliament) delivered by Mrs. Stina STANGREN from the European Parliament. The presence of two MEPs on site also allowed to deepen the role of the EU in terms of support to the civil society, and led to very rich exchanges among the French members and attendees.

This training was a very good opportunity to strengthen the ties between the Anna Lindh members from all over France during this difficult period, and the practical exercises allowed to build potential ways of cooperation in the framework of the new EU funding programs! The participants expressed their satisfaction with the quality of the training, its content, its methodology and pedagogy. □


In the participatory project "We are still here! EuroMed Citizen Reporters", citizens from the Euro-Mediterranean region

Training on intercultural competences – 21 April 2021

PARALLEL STORIES – INTERNATIONAL WOMEN’S DAY 8TH MARCH 2021

Parallel Story #1, Kenya and Ireland*

ALF Ireland member, Herstory, introduces Movement, a new international education project that explores the fact that migration and immigration are two sides of the same story.

Movement presents a series of parallel life stories of emigrants and immigrants connected by common narrative themes. The project highlights our shared humanity and the interconnectedness of people beyond nationality, ethnicity and religion; whilst spotlighting the discriminations and double

standards faced by immigrants and emigrants. The objective is to deconstruct the polarising rhetoric that define this era and co-create a new future inspired by the fundamental fact: we are One Humanity.

On International Women’s Day, 8th March 2021, phase 1 launched with a series of parallel stories, a student art competition and school workshops to foster diversity and inclusion in secondary schools. In these triggering times, the Covid-19 pandemic is a reminder that borders and nationalities are fabrications that conceal our common humanity.

On 25th May 2021, Herstory’s 5th birthday, phase 2 launches with an international exhibition of portraits and parallel life stories; a landmark light show, melting pot events, direct provision empowerment programme and the Parallel Peace Project with women’s organisations in Northern Ireland, Palestine and Israel.

This new Herstory project is produced in partnership with AkiDWA (Ireland), and Anna Lindh Foundation members: Jerusalem Centre for Women (Palestine), APIS Institute (Slovenia), Charisma Arts for Development (Egypt), and Agency for Migration and Adaptation AMIGA (Czech Republic). Movement celebrates the 20th anniversary of AkiDWA, Ireland’s first national women’s migrant service: www.akidwa.ie.

Migration is one of the few constants of the human experience. We are a migratory species. Homo sapiens have been travelling across the world long before the invention of the wheel. National Geographic maps reveal the extensive migration routes of our prehistoric ancestors. Diversity is not a modern buzzword. This is an ancient truth.

Movement is funded with the support of the Anna Lindh Foundation and co-funded by the European Union, the Beachaire Fund at the Community Foundation for Ireland, and philanthropists Abi and James Morrow.

WORLD BEYOND WAR: PEADAR KING IN CONVERSATION WITH DENIS HALLIDAY

As part of the Irish Chapter of World Beyond War, series of In Conversation with ALF member Peadar King spoke with former Assistant Secretary General of the United Nations Denis Halliday. Having worked for the United Nations for thirty-four years Mr. Halliday resigned in protest at what he regarded as the genocidal impact of the UN sanctions imposed on Iraq following the First Gulf War in 1991.

The Security Council of the United Nations has been a particular target of Mr. Halliday's critique of the UN.

"There are two United Nations", Mr. Halliday told me in our conversation. "There's the United Nations of the Security Council and the General Assembly where all 193 are equally represented. The five permanent members of the Security Council, China, France, Russia, the United Kingdom, and the United States browbeat and bully smaller countries into doing their bidding. They are also the major manufacturers and salespeople of military weapons; they are the aggressive nations; they are the people who violate the Charter and human rights. They are the guys who start the wars –Iraq, Afghanistan, and Libya. They are all guilty of violating the Charter. They are the guys with the nuclear weapons". Clearly, Denis Halliday does not mince his words. Nor should he. His views borne out of years of witness to what happens when the might of the military industrial complex is unleashed on defenseless people across the world.

And I have witnessed Denis Halliday's passion and compassion first hand. In 2019 we travelled together to Iraq for a documentary on the impact of the US and British-led 2003 war on Iraq that still leaves the country and its people reeling. Reeling and seething with anger at what has become of their country.

Just turned eighty years-of-age, and following his retirement from the United Nations, Denis Halliday continues to speak out against the insidiousness of the military industrial complex and continues to argue for reform of the Security Council.

Building citizenship



Open Call - Educate in Diversity

After meeting on November 5th 2020, Spain, Morocco and Belgium launched (in December) a call for educational, artistic and creative projects to their members! This call corresponds to the project «Educate in diversity. Building Citizenship» coordinated by the IEMed, funded by the Anna Lindh Foundation and the European Union.

Nine educational, artistic and creative projects tackling the positive impact of intercultural dialogue, which will combine several disciplines such as theater, plastic / visual arts and others. It will be carried out over the coming months in the various cities of these three countries. Together we promote the exchange of the know-how between these three countries through a pilot initiative which will be based on three fundamental pillars of our societies, which creates a responsible citizenship: youth, education and artistic creation. Several actions and interactive workshops will lead to the development of artistic productions and will take place in 9 different educational centers. 180 young people will have the opportunity to participate, thus being able to develop their social, civic and intercultural knowledge and skills. 72 educators will be trained to acquire practical skills in order to manage diversity in their centers and strengthen their work on intercultural dialogue. This will allow the multiplier effect which will benefit youth groups beyond the geographic and temporal scope of the project.

In addition, on December 9, the IEMed organized the dialogue "Environmental activism: from social networks to public and natural spaces" within the framework of the Forum "Youth and climate in the Mediterranean +25": a forum that encourages cooperation in the North-South and brought together a participation of 150 to 200 young people from both shores. Young people from Algeria, Egypt, Tunisia, Lebanon and Spain active in associations, collectives and movements in favor of the climate took the floor. These young people presented innovative initiatives and exchanged good practices through social networks and online platforms to create an impact in their countries and communities. □



Educating for Diversity Building Citizenship

From January to April, the Spanish ALF Network (ReFAL) was very active with the organization and monitoring of many projects and initiatives. On one hand, the workshops linked to the "Educating for Diversity. Building Citizenship" (see photograph) have been taking place since February with great success in Spain (leader of the project) and Morocco despite the COVID-19 challenges. The leaders of the 6 workshops are very happy with the results and have managed to overcome the complications. From ReFAL we want to congratulate their

excellent work. Unfortunately, in Belgium the 3 workshops could not start due to the confinement, therefore they will take place at the end of May. In June, the results of the project will be pooled and they will be used to collect a file of good practices which will be shared and disseminated. In addition, a video-recompilation of the workshops will be published. For now you can take a look at the two project "newsletters" that we have already published!

On the other hand, Thursday April 29 the Executive Committee of ReFAL met to discuss several actions that will take place during the months of May and June. Five entities of our network organize a debate each of which the aim is to listen to the opinions of the young participants (18-30 years old) in relation to themes around the axes: Future of Civil Society, Climate Resilience and Dialogue for Employability. In addition, on May 27, the European Institute of the Mediterranean (IEMed) will host a workshop on hate speech at institutional level as part of the "Intercultural Dialogue to Combat Hate Speech" project coordinated by the Egyptian network. Another call launched by our network recently, "On Participe! Let's move!", Will finance the travel costs of entities from different regions of Spain in order to promote and facilitate interaction and joint actions.

Finally, we are delighted to announce that very soon will be the call for the 14th edition of the "A Sea of Words" writing competition! The motto of this year will be: Youth and Mobility, towards a Euro-Mediterranean citizenship. □






Fundraising Training Course

Intercultural Dialogue- A Path to Peace

Vis-à-vis The Anna Lindh Report on Intercultural Trends, Head of Network of the ALF Turkey hosted the webinar titled “Intercultural Dialogue- A Path to Peace” on the 9th of April 2021.

The Webinar, held by Ms. Esmeralda Kashari, representative of System and Generation Association and backstopping member of the HoN of the Anna Lindh Foundation Turkey Network, aimed at analyzing the concept of Intercultural Dialogue, and its fundamental role in preventing ethnic, religious, linguistic and cultural clashes that may lead to convoluted conflicts.

During her analysis, Ms. Kashari explained in detail how, on the other hand, intercultural skills can enable communities to move forward together, to deal with different identities constructively and democratically on the basis of shared universal values. Furthermore, the webinar was tailored to explicitly focus on how youth involvement and active participation in international mobility projects can further foster intercultural dialogue.

The latter often seen, among other things, as a potential premise for a safe path to peace. The webinar was interactive and the focus of the thematic was also be substantiated by living experiences of young participants. □



Our 5+5 S2R French-Italian initiative for intercultural dialogue aims at enhancing the Greek-Roman historical and archaeological heritage, a fundamental resource for the Euro-Mediterranean dialogue, rediscovering the Mediterranean identities to create new jobs for youth and women in the cultural/tourist sectors, to fight labor-mismatch in our region.
