Applicants are informed of the following changes to the Guidelines for grant applicants

The Guidelines are corrected as follow:

SECTION 3.2. Terms of Payment – Page 4

Instead of:

- First instalment of pre-financing (60%) after signing the grant contract (excluding contingencies).

Read:

- First instalment of pre-financing (**70%**) after signing the grant contract (excluding contingencies).

SECTION 4.5. Eligibility of the Duration of the Implementation of the Project – Page 6

Instead of:

- The duration of implementation must be a **minimum of 8 consecutive months** and a **maximum of 11 consecutive months, and must start no earlier than 1 September 2020 and no later than 1 December 2020.**
- The end of the project implementation should be **no later than 31st of July 2021.**



Read:

- The duration of implementation must be a **minimum of 8 consecutive months** and a **maximum of 11 consecutive months**, and must start no earlier than **1 October 2020** and no later than **1 January 2021**.
- The end of the project implementation should be no later than **31st of August 2021**.
