The program, rooted in the principles of inclusivity and personal development, aligned with these standards, fostering a supportive environment where participants could exercise their right to education, recreation, and community engagement, thereby promoting the broader realization of human rights within the targeted communities. A total of 23 women participated in various aspects of the Line Up Live Up program. Gender mainstreaming was successfully implemented through targeted outreach, ensuring that activities and workshops were designed to be inclusive and sensitive to the diverse needs and perspectives of both male and female participants. This approach aimed at fostering equal opportunities and breaking down gender-related barriers within the community.

	Lessons Learned: Adaptability: the design of the program including sports activities allowed for better adaptation to the specific needs and dynamics of the participants Community Involvement: Actively involving the community (Municipalities, Mayors and representatives) in the planning process fostered ownership and increased program acceptance. Continuous Evaluation: Regular assessment and feedback mechanisms were crucial for refining the program and addressing challenges promptly. Our M&E officer Alexa Beany was every week updated and monitor several sessions.
Comments and recommended actions: What are the follow-up actions?	Our organization is committed to implementing LuLu programs in several villages. We will track the beneficiaries who have already participated and invite them to our NGO activities, encouraging their active involvement in community initiatives. Several requests were formulated by many municipalities in the Jbeil District to implement the LuLu program within their communities.
